#### KICKING OFF 2025 WITH TOGA'S FIRST MEETING

On January 23, TOGA kicked off the year with our first meeting at Smoky Mountain Brewery – Turkey Creek. A big thank you to **Stephanie Cross and Bart Smith** of **Jehovah Jireh Resources, LLC**, who sponsored our meal.

Our president, **Chuck Laine**, shared breaking news on **President Donald Trump's Executive Order**, titled "**Unleashing Prosperity Through Deregulation**." This directive mandates that for every one new regulation introduced by a federal agency, **at least ten existing regulations** must be identified for elimination. The policy is designed to **reduce the financial burden of federal regulations** on TN mining, Oil and Gas operations, and affiliated businesses by limiting new rules and eliminating outdated ones.

TOGA has identified seven key impacts of this EO:

- **Cuts Down on Regulations** For every new regulation introduced, 10 existing ones must be removed.
- **Limits Regulatory Costs** Agencies must ensure that 2025 regulatory costs are significantly lower than before.
- **Changes How Regulations Are Reviewed** The White House will have stricter oversight of new rules, including IRS policies.
- **Brings Back Older Cost Analysis Methods** The government will revert to traditional methods for assessing the cost-benefit balance of regulations.

- **Requires a "Regulatory Budget"** Agencies must submit a regulation budget similar to spending budgets.
- **Broadens the Definition of Regulations** Policy memos and guidance documents will now be classified as regulations.
- **Exempts Certain Regulations** Homeland security and immigration-related rules may bypass review.

A total of **43 wells** were permitted in **Tennessee in 2024**:

- 39 in Overton County
- 4 in Pickett County

- 18 Dry & Abandoned Wells
- 1 Domestic Gas Well

Additionally, there are currently **78 horizontal shale wells** in Tennessee. **In 2023, these wells account for 59% of the state's total gas production.**
